I am scheduling to have a company come who is highly recommended and has many state wide awards for work done on the home exteriors, to include Roofing, Windows, etc. If you are interested in coming over, please call me and let me know. ## Education Chair Report By Ed Linz

I spoke to each of the Principals in our three schools in the West Springfield pyramid. All were very cooperative and upbeat about what is taking place in their buildings. A universal concern among the Principals was the funding situation for Fairfax County Public Schools (FCPS). Due to budgetary constraints, class sizes continue to increase (now at 30.5 students per teacher at the high school level). Each of the principals indicated that their schools are “near the tipping point” and are in need of increased funding.

Mark Greenfelder, the prior WSHS Principal, was replaced by Mike Mukai just prior to the opening week of school. Part of Mr. Mukai’s previous experience has included both teaching Chemistry at WSHS and also being an Asst. Principal there, so he certainly is very familiar with the school and much of the staff. He reports that the **renovation remains on schedule to begin in early to mid-summer 2016 and will last “4 summers”** (if all goes well). Due to less students coming up the pipeline from Washington Irving Middle School, the overall population at WSHS will be perhaps 100 students less during the renovation. There will still be numerous trailers used during the renovation. The front of the school will be facing the current parking lot. New parking will be added in the current front area and there will be 644 total spaces when finished. The design is nearly completed, and the finished product should be quite attractive and functional. Mr. Mukai asked for patience from the community during the renovation, because most of the community meetings and activities currently being held at WSHS will not be taking place during the renovation

Danny Little, the Principal at Washington Irving, wanted to stress the increased use of technology in all disciplines at his school. There are now Smartboards in every classroom at Irving and there are 2 computers available for every student. Mr. Little's main concern was that he was going to lose 5 staff members (4 of which are teachers) due to declining enrollment in rising 7th graders and a small rising 8th grade class. It also appears now that high schools and middle schools in FCPS will be essentially swapping starting times beginning in the fall of 2015, that is, middle school students will be starting sometime between 7 and 7:30 and high school students between 8 and 8:30. If that sounds like robbing Peter to pay Paul, you’ve got it.

Enrollment at Orange Hunt Elementary School will be increasing, according to Jason Pensler, the Principal. He is expecting 850 students this fall, up from 790 two years ago. The German immersion program remains intact, and the school is enjoying the use of the new playground facilities (courtesy of a significant contribution by the PTA). Class sizes remain stable and student academic achievement continues strong. As most of you are aware, Monday schedules are now like every other day, with no early dismissal.

My overall impression of our local schools is that they are providing good value for money. Each has a very clean and safe environment (you have to be “buzzed in” to gain admittance). However, it appears that many of our students are doing better academically in their elementary years than as they progress up the academic food chain. I am not sure why this is taking place, but perhaps it is due to increased parental involvement for our younger children. What is certain is that active PTA participation peaks in elementary school, and declines dramatically in middle and high school. Bottom line: even if you no longer have children in our local schools, they deserve your support, and if you do have students, please stay involved.

One more non-education issue: the work on Huntsman Lake appears to be nearing completion. However, you should take official information on completion dates with considerable skepticism. Every time I talk to the actual workers, they say, two more months.” The lake may be full by spring.

## Highlights from the 4th of July Parade and Ice Cream Social

The weather was perfect for the annual Orange Hunt and Winston Knolls 4<sup>th</sup> of July parade. Once again the streets were lined with anxious parents, grandparents and neighbors waiting for the parade to begin. Besides the residents having a super time marching in the parade, State Senator Dave Marsden, Supervisor Pat Herrity, and Delegate Eileen Filler-Corn also attended the festivities and chatted with parade-goers. Additionally, Cub Scout Pack 685 and 686 set up a static display providing information on the scouting program. **Bringing the FBI to Springfield:** The GSA warehouse site is on the shortlist of sites being considered for the FBI's new headquarters. The GSA site is optimal because it already has in place, transportation facilities, communications infrastructure, shopping amenities, and hotels and restaurants that the FBI and its employees will need to be successful. In addition the GSA site is right up 95 from the FBI's training facility in Quantico. The Greater Springfield Chamber of Commerce fully supports relocating the FBI headquarters to Springfield, and it wants to show the decision makers that our citizens do too. The Chamber created this petition and I urge you to sign it and show your support today!

**Reimbursement for Unaccompanied Minors:** At Tuesday's Fairfax County Board of Supervisors' meeting, I asked the County Executive to calculate the costs associated with providing services to the over 1,000 unaccompanied minors now in Fairfax County, and to look at options to recover the money for these services from the Federal government, either directly or through the Commonwealth. The influx of unaccompanied minors across the southern border of the United States is in the tens of thousands. According to the Office of Refugee Resettlement the number of these children now in Fairfax County stands at 1,023 - one of the largest in the country. Unlike in Prince William County where children were placed primarily in one center with the costs reimbursed primarily by the Federal government, the children currently in Fairfax County have been placed with family members and none of the costs are being directly reimbursed by the Federal government. These children will be using a multitude of County services including County schools. At the cost of \$14,755 per English as a Second Language student (per FCPS approved FY14 budget), that could mean that Fairfax County schools alone will have over \$14M in new unexpected expenses to deal with in this school year. I also believe it is important for us to know the extent to which this influx will affect both ours and the schools' budgets - \$14M is no small chunk of change, especially in this difficult economy. It is the Federal government who is placing these children in our communities that should be paying for the services that localities have to provide while they are here. The over \$14M figure is just the cost of basic ESOL services.

**Great News for Old Keene Mill Road:** The Virginia Department of Transportation began the repaving of Old Keene Mill Road/Franconia Road (Route 644) from Elder Avenue to Rolling Road this week. The work will occur five nights a week, Sunday through Thursday from 9 p.m. to 5 a.m. This work is expected to take about three months to complete, weather permitting. Many of the County's roads are in disrepair and VDOT is working to address them as quickly as they receive the funds. Old Keene Mill Road has been in a state of disrepair for quite some time now and I glad we were able to work it on to this year's list. I am also working to get a short section of Union Mill Road done this year. Several other major arteries were paved earlier this year. I know firsthand that the section of Old Keene Mill Road between the Fairfax County Parkway and Rolling Road is just as bad as the section being repaved. VDOT tells me this is on the radar; it could be completed later this year or next season. This also applies to the section of Rolling Road between Braddock Road and Burke Road. I also hope VDOT will be able to make it into our neighborhoods next year as well.
