Dear Neighbors and Friends, -The last couple of years have been very trying for all. But it looks like we have turned the corner and we are starting to get back to normal, although it may be another several months to completely get back to where we were in 2019. I want to thank you for your contributions in making our community a great place to live and those individuals who came out and supported our annual meeting in February. Besides the normal business of the association, the 2022 Budget was passed along with the election of Officers. A big thank you goes out to Pat Herrity for speaking and taking questions from the crowd. Pat spoke on several issues that dealt with taxes, local school concerns, road /street paving, and etc. The top three officers for WKCA 2022 are, President: Tom Blume, Vice President: Jeff Lins, Treasurer: Kathy Howard and the Secretary position remains vacant. All three positions were elected by acclamation. In addition, John Flynn has volunteered to be our new Data Base and Directory Chairperson, he replaces Kathy Sherman after 7 years of faithful service. As you can see from the front page, the WKCA Membership drive has started and we are striving for at least 290 (61%) of the 489 houses to pay their 2022 dues, in order to pay our basic bills. Although, Fairfax County has not resumed the Large Pick Up events that we host at the Orange Hunt Elementary school twice a year, we are planning to try and get back to normal with our activities and events. We will host the Community yard sale in May 14 and are planning to have a dumpster of our own at the corner of Spur and Huntsman - late May. In addition, we are in coordination with OHECA to look in to the possibility of having the local 4th of July Parade -a favorite that we have missed over the past two years. In closing let me wish everyone a good spring/summer, now that COVID-19 is not as dominant in our lives as it has been in the past two years. However, we must remain on our guard and use common sense – please stay safe.

# Scams the US government wants you to know about

The Federal Trade Commission has put out some tips on how to avoid being defrauded, and how to report scams to the government. Some of the common scams the FTC says to be aware of are:

- Social Security scams: Some fraudsters might pretend to be from the Social Security Administration and your social security number, or even money. Be aware of this.
- Phishing: Be highly aware of any suspicious emails or text messages and either use your email's, delete the message, and never click on any strange links from unknown senders. Beware of generic greetings like "Hi Dear."
- Unemployment benefit scams: Claims for unemployment benefits by imposters have been reported.
   Report fraud to your state's benefits agency,
- Phone scams: Be aware of, and from anyone asking you for personal information over the phone. Never send cash or pay for something with a gift card over the phone. Some scammers might even pretend to be law enforcement to scare you.

# Higher Education By Ed Linz, Education Chair

With much of the news lately focused on the Russian invasion of Ukraine, it is very easy to lose sight of a pivotal legal case, Students for Fair Admissions v. President & Fellows of Harvard College, which the U.S. Supreme Court has just agreed to hear. The issue surrounds admissions policies at Harvard which was sued eight years ago by applicants (mostly Asian-Americans) who were denied admission on what they alleged to be factors based on race rather than academic excellence. Lower courts have consistently sided with the universities, and before agreeing to hear the case, the Supreme Court asked the U.S. Solicitor General to state the federal government's position. Recently, in response, the Biden administration urged the Court not to take the case. But apparently the Supreme Court has been looking for a case to decide on affirmative action programs and decided to take the case. It is expected that arguments will begin this fall when the Court, with a new member (probably Ketani Jackson Brown who has been nominated by President Biden).

Assuming that Judge Brown is confirmed to the Court, she will be under considerable pressure to recuse herself (making her ineligible to vote) due to her past position for many years on the Harvard Board of Overseers. It is safe to assume that this issue will be raised during her confirmation hearings. Of course, all eight of the current Justices are graduates of Harvard or Yale, with half of the current eight Harvard grads. So much for impartiality!

Harvard is not sitting still awaiting the outcome of the case. Just in the event that they lose, they have already taken pre-emptive action which may affect you if your child will be seeking admission to any university in the future. They have recently dropped the requirement for applicants to submit national standardized test scores such as the SAT's or ACT's which are at the heart of the plaintiff's claim against Harvard. If there are no longer any such test scores, how will anyone be able to claim that Harvard (or any other college which has

dumped the SAT/ACT requirement) has discriminated against them by taking applicants with lower test scores when there are no test scores? Basically, they will be free to take whomever they choose with no fears of being sued for discrimination. Grades, of course, will remain important, but let's be very frank here: having a high GPA or even straight A's "ain't what it used to be." Harvard (and other "selective schools" will be able to base selection on where you went to school, such as prestigious (very expensive) prep schools, race, diversity, sexual orientation – whatever they wish to use. Your student at West Springfield, Lake Braddock, even Thomas Jefferson can be easily overlooked even if they have perfect SAT scores! They are no longer a factor.

Some other universities, such as the California state universities, have gone so far as to refuse to accept any SAT scores, ensuring that they will be totally exempt from second-guessing their admission policies. Once other universities with competitive admissions see how cleverly Harvard has protected itself from further legal challenges in the event that the Supreme Court rules against them, those institutions will also dump the SAT/ACT requirements. Bottom line: we are all about to enter a new era of how colleges select candidates for admission. Good luck!

## **Keep your Yard and Street Neat!**

I would ask all residents to remember to remove your trash cans from the street and store them accordingly, once they have been emptied. Letting the trash cans sit in the road empty overnight or for several days is not recommended. Also, if you have branches or lawn trash -- please ensure that you properly tie up or bag the yard debris for pickup. If not the debris will not be picked up by your trash company and blow away in the street, possibly ending up clogging one of the many storm drains.

### Relationship between the WKII HOA and the WKCA

In an attempt to clear up the confusion between what the Rolling Valley Section 8-D Homeowners Association (WKII HOA) is responsible for and what the Winston Knolls Civic Association (WKCA) does, please read the following. The WKCA was established in 1975 as a non-profit organization to promote the common interests of the Winston Knolls community. Membership for the WKCA is purely voluntary and we have 489 homes in the area, however only 53 percent renewed their dues for 2021. The Annual dues are a very modest, \$20.00 dollars, which pays for all of the activities and mowing, our website is www.wknolls.net. The establishment of the WKII HOA, a total of 191 homes constituting Winston Knolls II, was mandated by Virginia law because WKII owns three parcels of common land. A description and detailed map can be found at www.winstonknolls.org, identifying the 191 homes and the parcels of common land. Membership is mandatory for these homes with the annual dues voted on by the HOA Board of Directors. Please visit the website for the HOA Officers, Board members and other information. The primary expenditures of the HOA are liability insurance, mowing portions of the common land, and periodic removal of trees that are identified by professionals as an unacceptable risk for falling on neighboring homes. The HOA is also responsible for declarations and covenants enforcement and home re-sale/disclosure documents. The HOA and the WKCA continually explore opportunities for joint sponsorship of activities that are consistent with their respective missions. For example, the HOA and the WKCA sponsor Dumpster Day at spur Road, providing Winston Knoll resident's disposal of trash and debris for spring and fall clean-up and maintains an active dialogue between the WKCA and HOA Board members for the betterment of the community. By the way, if you live in Winston Knolls II, the HOA Board is seeking volunteers to fill positions of long serving officers and members who would like to turn over their role to new individuals. # **Medical identity theft**

When most people hear identity theft, they think of someone stealing their credit card info and buying a big-screen TV. But you can't legally be held liable for fraudulent purchases like that. It's different, however, with medical identity theft. "You can be required to cover the cost for health care services you never received. These can include tests, prescription drugs and even operations. Your Plan Never surrender Social Security, Medicare or health insurance numbers to anyone you don't know and trust. Be particularly wary of free health checks offered at shopping malls, fitness clubs and retirement homes (so-called rolling labs). If they ask to photocopy your cards or ask you to sign a blank insurance claim form, don't do it. It's also vital to review all statements from your insurance provider. If there are any charges you don't understand, call immediately. And when shopping online for prescription drugs or other health-related items, remember that if a price seems too good to be true, it probably is.
